

HOUSE RULES: "SPRING 2017 50-50 RAFFLE"

EVENT DATE: May 13th, 2017 9am-6pm -- tickets sold from 9am-5:30pm

PRIZE DRAW: 6pm (just prior to closing)

TICKET PRICES: \$1/ticket, \$4 for 5 tickets

TICKET SALES

Tickets are sold from 9am until 30 minutes before the close of the raffle event.

Ticket prices are \$1/ticket, \$4 for 5 tickets.

WINNING TICKET DRAW

Winners are drawn immediately on the day of the raffle event at the Ann Arbor PTO Thrift Shop (2280 S Industrial Hwy, Ann Arbor, MI 48104).

All prizes are awarded as stipulated in these HOUSE RULES.

Ann Arbor PTO Thrift Shop Board & Executive Directors are ineligible to win.

Individuals need not be present to win.

CLAIMING PRIZES

Winners must present ticket stubs and valid ID to a Manager at the Ann Arbor PTO Thrift Shop (2280 S Industrial Hwy, Ann Arbor MI 48104) during published operating hours on our website (www.a2ptothriftshop.org) to claim raffle prizes.

Please retain ticket stubs and provide legible contact information on the back of each raffle ticket!

Winning ticket numbers will be posted and publicized in the Ann Arbor PTO Thrift Shop and SHOWCASE (2280 & 2284A S Industrial Hwy), on our Facebook page (@A2ptoThriftShop), and on our website (www.a2ptothriftshop.org) to help facilitate the notification and awarding of prizes.

PRIZES

50% of all ticket sales income will be awarded in prizes up to **\$500.00 per individual winner**. *There will be no tax withholding on individual prizes as a result.

PLEASE NOTE that multiple winners may result if over \$1000.00 in ticket sales income is collected during the day of the raffle event and will be determined as follows:

50% of ticket sales will be awarded to the **FIRST** ticket stub holder drawn (at approximately 6pm on the day of the raffle event) **up to a 1st prize maximum of \$500.00 (50% of \$1000.00 in ticket sales income).**

*If less than \$1000.00 in ticket sales income is collected during the day of the raffle event then only ONE PRIZE of \$500.00 or less will be awarded equalling 50% of the total ticket sales income.

In the event that ticket sales on the day of the raffle event exceed \$1000.00 then a **SECOND PRIZE winning ticket stub will be drawn worth 50% of the ticket sales income OVER \$1000.00 **up to a 2nd prize maximum of \$500.00 (50% of \$1000.00 in ticket sales income).**

*****SUBSEQUENT PRIZES of \$500.00** or less (equalling 50% of the remaining ticket sales income) will be drawn **until 50% of the total ticket sales income from the day of the raffle event is awarded in prizes.**

Individuals are limited to ONE PRIZE: a new individual winner will be drawn if a winner is repeated in a subsequent prize draw on the day of the raffle event.

REMEMBER: Prize stubs should include names & contact information so please print clearly and carefully!

Winners will be notified by phone and/or email (where possible based on contact information provided) immediately following the prize draw at the close of the day's ticket sales. All attempts to contact the winners as drawn will be made per State of Michigan gaming regulations. **Winners must present valid, current ID.**

PRIZES will be awarded by check from the Ann Arbor PTO Thrift Shop, Inc., payable to the winner. Raffle prizes are subject to applicable State and Federal taxes.

Ticket stubs will be retained by the Ann Arbor PTO Thrift Shop, Inc. until all winners have been contacted and confirm acceptance of prizes from the raffle event.

REFUNDS may be offered up until the prize draw. Please make all refund requests to the Manager on duty. A refund of the ticket price may be granted to any prize winner who is unable to accept the raffle prize within 7 days of their prize draw.
